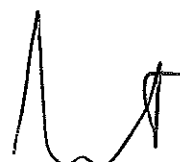

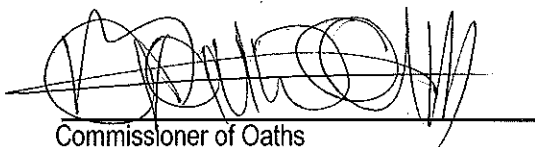



3. I hereby declare under Oath that:

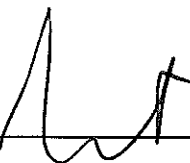
